How you can help

There are many ways of donating towards good causes through BEHT:

Capital costs e.g. sponsoring a building

BEHT has many different projects going on in India at any one time. There is always a need for donors who can sponsor whole or part of a Building project. Also donors are required for fixtures and fittings. If you are interested in donating a substantial amount towards a capital project, please contact BEHT for further information.

Sponsor a child scheme

A donation of £ 401 annually will educate and board 1 child. BEHT has approx. 3000 children in total receiving education at the 4 centres Chaparda, Adhoi, Junagadh & Savarkundla

Feeding children and elders on a special day.

For a special day, like anniversaries, birthdays, marriage, or religious occasion like Paryushan or in memory of a departed loved one (tithi) - Donation of $\mathfrak L$ 400 (1 meal a day) or a donation of $\mathfrak L$ 1000 (3 meals a day) will feed about 1500 children, elders and staff on that day in Chaparda.

Feeding all the animals in the dairy farm.

A donation of $\mathfrak L$ 121 will help to feed about 300 cows in the dairy farm for a day, which produces milk for the children, elderly and staff at both the schools.



Sponsor an elderly person scheme

A donation of £ 301 annually will help to provide boarding, food, clothes, medicine and other expenses for one elderly person for one whole year. BEHT has about 120 elders in residence at Chaparda and another 50 at Mehendarda in Junagadh District.
